American Electric Power Service Corporation (“AEPSC”), on behalf of its affiliates, Appalachian Power Company, Indiana Michigan Power Company, Kentucky Power Company, Kingsport Power Company, Ohio Power Company, and Wheeling Power Company (collectively “AEP” or “the AEP East Operating Companies”), hereby submits for filing for informational purposes a correction to its true-up of its 2021 annual transmission revenue requirement (“2022 Annual Update”) filing made May 25, 2022. Following the May 25 submittal, it was found that the total amounts for Appalachian Power Company and Wheeling Power Company did not flow up to the “04 ATRR FR Summary 2021.xlsx” nor the “03 Formula Rate Update AEP Operating Company Summary.doc” files. Both files have been revised and are attached to this filing as “04 ATRR FR Summary 2021 vs – Revised 5-27-2022.xlsx” and “03 Formula Rate Update AEP Operating Company Summary – Revised 5-27-2022.doc”.
