Purpose

The “Hazardous and Solid Waste Management System: Disposal of Coal Combustion Residuals From Electric Utilities; Legacy CCR Surface Impoundments”, 89 Fed. Reg. 38950 (May 8, 2024) (amending 40 C.F.R. §257) requires owners and operators of inactive electric generating facilities to prepare documentation on the applicability of the rule for each legacy CCR surface impoundment at the facility. Ohio Franklin Realty and Ohio Power Company are owners of the Poston Site, which has been inactive since October 30, 1987, and is subject to the rule.

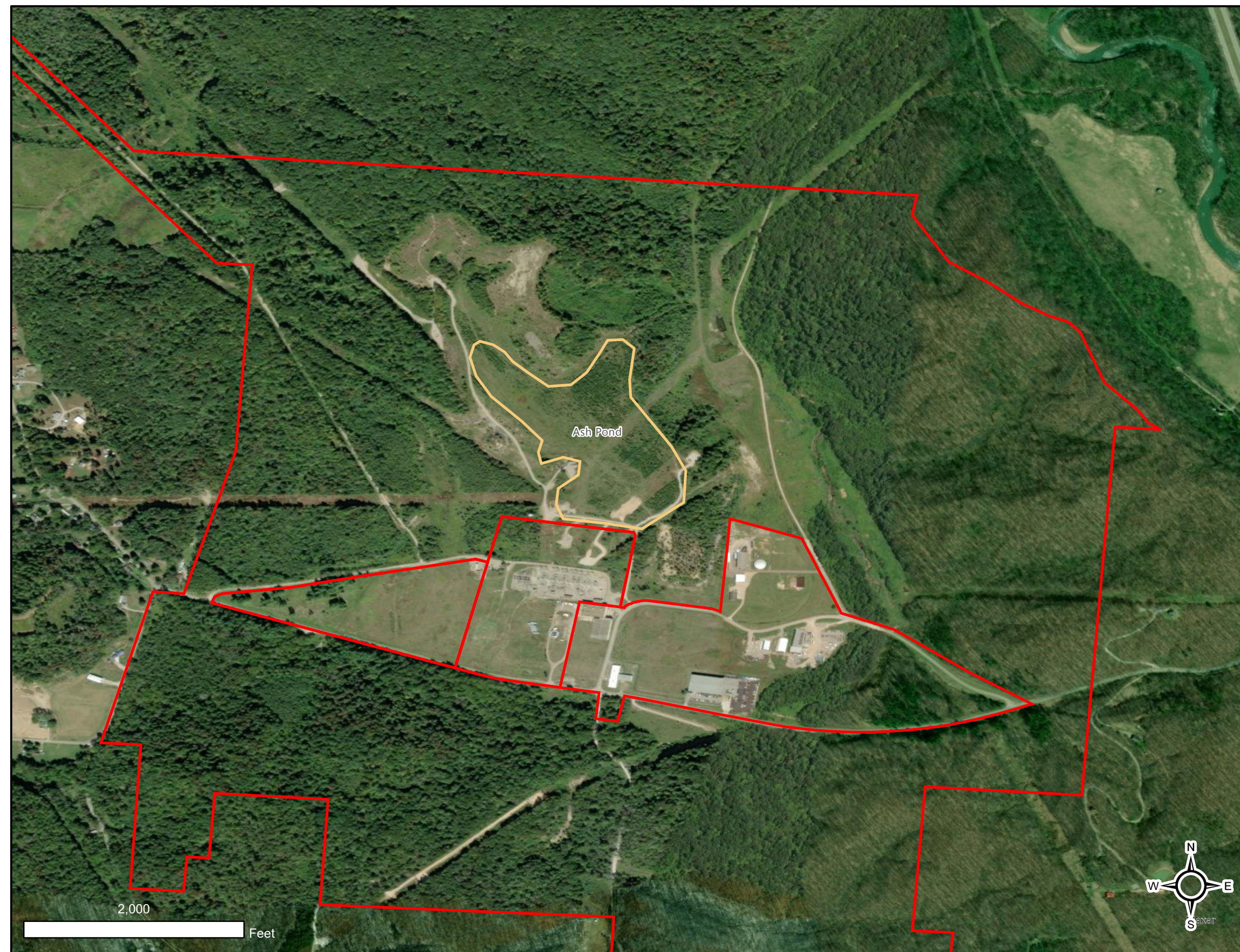
