American Electric Power Service Corporation, on behalf of its affiliates, AEP Appalachian Transmission Company, Inc., AEP Indiana Michigan Transmission Company, Inc., AEP Kentucky Transmission Company, Inc., AEP Ohio Transmission Company, Inc., and AEP West Virginia Transmission Company, Inc. (collectively referred to herein as the "AEP East Transmission Companies"), hereby submits for filing for informational purposes a 2014 Annual Update to its annual transmission revenue requirements ("Annual Update"). This Annual Update is submitted pursuant to section 1(b) of the Formula Rate Implementation Protocols found in Attachment H-20A of the PJM Interconnection, L.L.C. ("PJM") Open Access Transmission Tariff ("OATT").
