Dear Secretary Reese:

American Electric Power Service Corporation ("AEPSC"), on behalf of its affiliates, AEP Oklahoma Transmission Company, LLC ("OKTCo") and AEP Southwestern Transmission Company ("SWTCo") (collectively referred to herein as "AEP" or the "AEP West Transmission Companies"), hereby submits for filing for informational purposes their 2025 projected annual transmission revenue requirement ("PTRR"). This PTRR is submitted pursuant to Attachment H, Addendum 12 of the Southwest Power Pool, Inc. ("SPP") Open Access Transmission Tariff ("SPP Tariff")¹, which was accepted by the Federal Energy Regulatory Commission by letter order issued on June 28, 2019, in the above-referenced docket. The PTRR includes fully populated Microsoft Excel files with formulas intact.

As discussed in the 2024 Annual Update filed on May 28, 2024, pursuant to the Commission's January 18, 2024, Order ("January Order") in the above-captioned docket, AEP submitted a compliance filing on March 18, 2024 ("Compliance Filing"). In the Compliance Filing, AEP calculated refunds related to the January Order to provide to customers consistent with Section 6 of the AEP West Transmission Companies' Formula Rate Protocols. The Base Plan refunds associated with Schedule 11 of the SPP Tariff, with interest, will be provided throughout the 2025 rate year and are reflected in this PTRR. AEP provided the NITS refunds, with interest, in its July 2024 billings.

The 2025 PTRR is effective January 1, 2025. The PTRR reflects AEP's corporate budgeting process to estimate costs associated with planned capital projects and anticipated operations and maintenance expenses in 2025. The PTRR contains no expenses or costs that have been alleged or judged in any administrative or judicial proceeding to be illegal, duplicative, or unnecessary costs that are demonstrably the product of discriminatory employment practices, as defined in 18 C.F.R. § 35.13(b)(7).

The AEP West Transmission Companies have made no material changes in their accounting policies and practices from those in effect during the previous Rate Year and upon which the current rate is based.
